- · The government and society need to recognise that we have GA in Ireland. The Working Group for the Gambling Control Bill need to re-invite the experts in GA into discussions and take on board and welcome the advice given to them to avoid an epidemic of GA in Ireland.
- · Along with the growth of technology, a clear stance needs to be shown to the gambling industry here in Ireland that we will no longer support them if there are not strictly regulated.
- · For example, self-exclusion options for people who are experiencing GA should be pain-free and easily put in place.
- · Similarly, to people with a drug or alcohol addiction if people wish to start recovery from SAGA there needs support for them at a societal level..
