



Screenshots from online drug shops in Ukrainian (left, 'Matanga-Shop') and Georgian (right, Telegram channel)





Shift in drug use: from traditional home-made substances to (imported) synthetic substances, including a shift away from heroin and towards 'street methadone', methamphetamine and NPS, esp 4-MMC and α -PVP.

Shift in **drug use: from traditional home-made substances to (imported) synthetic substances**, including a shift away from heroin and towards **'street methadone'**, methamphetamine and NPS, esp 4-MMC and α-PVP.

Reasons increased use of synthetic opioids: low purity of heroin, low cost of street methadone and of diverted OST medications.

Catalysers of key findings 1+2

- COVID pandemic: closed borders, COVID restrictions, curfews etc
- Invasion of Russia in Ukraine

• Drug markets are likely shifting:

√ Trafficking routes disrupted, esp cocaine and heroin trafficking routes

V Domestic production (esp UA) street methadone, and NPS, disrupted: lack of precursors.

However: drug markets seem resilient and appear to be restored

- While the drug markets are likely shifting, there does not appear to be a dramatic change in **drug use** that is currently of concern.
- Rather, both PWUD and service providers highlight the disruptions in drug-related service provision incl. OST in some areas.

Some recommendations

- To initiate structural and systematic monitoring of dynamic online drugs markets,
- To initiate or expand internet-based outreach work among online communities of PWUD, and to
- Introduce and improve essential services such as consumer drug checking services and other harm reduction and treatment services that meet the needs of people who use methamphetamines and NPS.

First and foremost

 Stakeholders at regional, subregional and local level should first and foremost aim to restore and expand the provision of the full spectrum of drugrelated services including harm reduction services and to restore the accessibility and availability of necessary medication such as methadone and buprenorphine in all areas.
